Razvojna agencija Sinergija - Development Agency Sinergija was established in 1998 as a sub-regional development agency for 11 municipalities in Pomurje Region and is responsible for their development project preparation and execution.

DA Sinergija is non-profit organization; body governed by public law (*according to Directive 2004/18/EC, Art. 1*) with legal status of non-profit Ltd owned by founder municipalities & chambers.
